THE GRAND JURORS of Lauderdale County, Tennessee, duly empaneled and sworn, upon their oath, present that CURTIS RAY WATSON, on or about August 07, 2019, in Lauderdale County, Tennessee, and before the finding of this indictment, did unlawfully, feloniously, intentionally and with premeditation kill Debra Johnson, in violation of T.C.A. 39-13-202, against the peace and dignity of the State of Tennessee.

COUNT 2

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and recklessly kill Debra Johnson during the perpetration of burglary, in violation of T.C.A. 39-13-202, against the peace and dignity of the State of Tennessee.

COUNT 3

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and recklessly kill Debra Johnson during the perpetration of rape, in violation of T.C.A. 39-13-202, against the peace and dignity of the State of Tennessee.

COUNT 4

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and recklessly kill Debra Johnson during the perpetration of kidnapping, in violation of T.C.A. 39-13-202, against the peace and dignity of the State of Tennessee.

COUNT 5

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and without the effective consent of Debra Johnson, the owner of the habitation, enter the habitation, which was not open to the public, with intent to commit rape and did cause serious bodily injury to Debra Johnson, in violation of T.C.A. 39-14-404, against the peace and dignity of the State of Tennessee.

COUNT 6

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and without the effective consent of Debra Johnson, the owner of the habitation, enter the habitation, which was not open to the public, with intent to commit assault and did cause serious bodily injury to Debra Johnson, in violation of T.C.A. 39-14-404, against the peace and dignity of the State of Tennessee.

COUNT 7

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and forcibly, while armed with a weapon, towit: box cutter, sexually penetrate Debra Johnson, in violation of T.C.A. 39-13-502(a)(1), against the peace and dignity of the State of Tennessee.

COUNT 8

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously and knowingly sexually penetrate and cause bodily injury to Debra Johnson, in violation of T.C.A. 39-13-502(a)(2), against the peace and dignity of the State of Tennessee.

COUNT 9

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously and knowingly confine Debra Johnson so as to interfere substantially with Debra Johnson's liberty, and Debra Johnson suffered bodily injury, in violation of T.C.A. 39-13-304(a)(4), against the peace and dignity of the State of Tennessee.

COUNT 10

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously and knowingly escape from West Tennessee State Penitentiary, a penal institution, located in Lauderdale County, Tennessee, having been lawfully held there due to a conviction for Especially Aggravated Kidnapping, in Henry County, Docket #15180, a felony, in violation of T.C.A. 39-16-605, against the peace and dignity of the State of Tennessee.

COUNT 11

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 07, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously and knowingly obtain property to-wit: 2015 New Holland Work Master 70 tractor, a more particular description thereof being to the Grand Jurors unknown, valued at ten thousand dollars (\$10,000) but less than sixty thousand dollars (\$60,000), of West Tennessee State Penitentiary without its effective consent, with the intent to deprive said West Tennessee State Penitentiary thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.

COUNT 12

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County between August 07, 2019 and August 11, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully, feloniously, knowingly and without the effective consent of David and Lori Green, the owner of the storage trailer, enter a building other than a

habitation which was not open to the public with the intent to commit theft, in violation of T.C.A. 39-14-402, against the peace and dignity of the State of Tennessee.

COUNT 13

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County between August 07, 2019 and August 11, 2019, before the finding of this indictment, the said CURTIS RAY WATSON, did unlawfully and knowingly exercise control over property to-wit: camouflage jacket, camouflage pants and belt, black backpack, black Under Armour cold gear pants, binoculars, 2 knives, compass, scent away and folding tree saw, a more particular description thereof being to the Grand Jurors unknown, valued at one thousand dollars (\$1,000) or less, of David and Lori Green without their effective consent, with the intent to deprive said David and Lori Green thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.

COUNT 14

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 11, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully enter the property of Harvey Taylor knowing at the time that he, the said Curtis Ray Watson, did not have the effective consent of the said Henry Taylor to do so, with the knowledge on the part of the said Curtis Ray Watson that his presence will cause fear for the safety of Harvey Taylor and his family, in violation of T.C.A. 39-14-406, against the peace and dignity of the State of Tennessee.

COUNT 15

And the Grand Jurors on their oath aforesaid further present that in Lauderdale County on or about August 11, 2019, before the finding of this indictment, the said **CURTIS RAY WATSON**, did unlawfully and knowingly exercise control over property to-wit: food, a more particular description thereof being to the Grand Jurors unknown, valued at one thousand dollars (\$1,000) or less, of Harvey Taylor without his effective consent, with the intent to deprive said Harvey Taylor thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.
