By involving yourself in a sexual relationship with a defendant you charged has potentially damaged the murder case against her and her co-defendants. This has also placed increased scrutiny on your past and current cases. Your actions have tarnished your reputation and your ability to be relied upon in active and upcoming cases. This places you in violation of Memphis Police Department DR 304 Compromising Criminal Cases which states:

DR 304 Compromising Criminal Cases

A member shall not make any promises or arrangements with prisoners or between a suspect and his victim intended to permit the offender to escape the full penalty provided by law, or interfere with the courts, or for personal gain or benefit, use their official position to make any arrangements for any suspect or prisoner to escape prosecution.

In your statement to ISB investigators you stated you did not buy or provide marijuana to the defendant. You also stated you did not refer her to anyone to purchase marijuana. In text messages you sent to the defendant you give the name and address of a person for the defendant to meet and purchase marijuana. You tell the defendant you will get her some "green". You were also deceitful in telling investigators the defendant would be used as a witness in the murder case. You allowed the defendant to travel with you and another investigator on a City of Memphis sponsored out of state trip. You advised the defendant slept in your hotel room but in a separate bed. The defendant refuted that statement and advised there was only one bed and you shared it with her. This places you in violation of Memphis Police Department DR 108 Truthfulness, which states:

DR 108 Truthfulness

A member shall not give any information, either oral or written, in connection with any assignment or investigation that is either knowingly incorrect, false, or deceitful.

The defendant informed you she had a warrant in Haywood County. In text messages you asked for her date of birth, social security number and driver's license number. You queried the defendant on December 12, 2018, at 11:08 pm, 11:09 pm, 11:20 pm and 11:21 pm. You informed the defendant she only had a suspended driver's license. Your queries did not have anything to do with the murder investigation but was relative to your personal relationship. In your statement to investigators you stated your query was personal. This places you in violation of Memphis Police Department DR 608 Accessing Reports & Records with No Legitimate Purpose, which states:

DR 608 Accessing Reports & Records with No Legitimate Purpose

A member shall not access official offense reports, departmental records or information concerning police matters without a legitimate law enforcement purpose.

The defendant traveled with you on a work related trip to Montgomery, Alabama in a vehicle issued to you by the City of Memphis. You did not receive authorization for the defendant to

travel in the vehicle. This places you in violation of Memphis Police Department DR 903 Unauthorized Passengers, which states in part:

DR 903 Unauthorized Passengers

A member shall not allow unauthorized passengers to ride in any vehicle of this Department, unless specifically authorized by competent authority and in compliance with Department orders and directives.

While on the trip you were issued a traffic citation for Speeding. Upon returning to Memphis you did not inform your supervisor in a written memo that you were issued the citation. This places you in violation of Memphis Police Department DR 125 Member Under Investigation which states in part:

DR 125 Member Under Investigation

A member shall immediately submit a written memo to their supervisor/commanding officer that they have been issued a misdemeanor citation or citation for any misdemeanor offense (including traffic citations while off-duty), arrested for any misdemeanor/felony offense or is being sued in a court of law.

You were involved in a sexual relationship with a defendant who had been arrested ten (10) times before you charged her with Accessory after the Fact to wit: First Degree Murder. The defendant's charges range from Possession of a Controlled Substance, Driving Offenses, Shoplifting, and Drug Paraphernalia to Underage Drinking. You stated to investigators you were aware of her criminal history and gang affiliation. You stated police in Haywood county were aware of her criminal history. This places you in violation of Memphis Police Department DR 110 Consorting With Persons of Bad or Criminal Reputation, which states:

A member of this department shall not knowingly socialize or have a business relationship with another person, who has been imprisoned or convicted of a felony, or who are known criminals, except in the performance of their official police duties.

Deputy Chief Samuel Hines, Jr. read the allegations of the complaint that said in part: On March 1, 2018 you were the lead investigator of a murder case and began a sexual relationship with a defendant you charged in this case you provided the defendant with marijuana and allow her to take photos inside your residence with several of your firearms. This conduct is unbecoming of a law enforcement officer and places you in violations Memphis Police Department DR-104 Personal Conduct which states: The conduct of each member, both on and off-duty, is expected to be such that it will not reflect adversely on other members, the Department, the City of Memphis, or the law enforcement profession. This regulation applies to both the professional and private conduct of all members. It includes not only all unlawful acts by members but also acts which, although not unlawful in themselves, would violate either the Law Enforcement or Civilian Code of Ethics, and would degrade or bring disrespect upon the member or the Department.

Lt. Eric Kelly was offered an opportunity to comment on the allegations. Lt. Kelly began by apologizing to Chief Hines, Colonel Oakley and Lt. Col. Jackson for this entire situation. He explained, it was not on their watch that this happened. It occurred over a year ago before I even got promoted. I know that this is at a minimum a total embarrassment on a certain level for this to be dropped in you guys lap. I'm not here to "bs" or snowball, there's stuff that occurred that I have to take full responsibility for that I will do. But, I do have a problem with the categorization of certain things that in regards to other Statement of Charges that are in there. Addressing the first one Personal Conduct, the way they have it written here I would say that on a certain level that I would acknowledge that it was Personal Conduct. But again, I take issue with how it was categorized. It reads as if I was in a sexual relationship with this woman... the way it was presented to me from the gentlemen from ISB was that I had forced a statement out of a person in exchange for sexual favors. That's how it was presented to me. That is inaccurate and not true. They eventually...again I admitted to them that there was some sexual contact between me and her. But it was not as if I entered into this situation to just have sex with a girl. The genesis of my involvement with even becoming personally involved with her was in regards to the homicide case that... she was technically a witness case, who I tried to make multiple efforts to contact her to get her to come in to speak with me to confirm some stuff involved in the case. She had no direct involvement with the homicide at all. And the prosecutor on the case at the time who has since quit and the prosecutor who has it now is Jose Leon and... (Lt. Kelly unable to recall the name of the other prosecutor) there was a warrant that was issued for her and it was what we refer to as a "twist of arm"... it was a warrant that I issued by gleaming over the facts. I am very good at writing stuff to get stuff accomplished. It was written up, and if you read the warrant it does not directly say that she did anything it just alludes to and it passed the mustard with the judicial commission and it was issued. She's arrested and brought to the office and there's an interview. As I do with anybody that I talk to even with suspects I tell them, I give a card and I tell them look...if they are garbage completely, if they were heinous, or if what they did is totally jacked up, then there's no hope for them. I on many occasions have offered my business card to people and tell them if you need some help with stuff, holler at me and I will see what I can do to help you get to where you trying to get to, which is what happened in this particular situation. That evolved into contact with her, interpersonal contact with her. And actually the first time I came into contact with her was down in court. I had court and something and she had court and actually Jose Leon met up with her and spoke with her down there in court. And that's where she asked me for my number and called again because she was trying to get herself together. This information about her taking photos inside my residence with my firearms, I had no clue. But I do have several firearms, they showed me pictures but I was not aware of and didn't know that she had taken pictures with the firearms. So again, they are listing that up under the Personal Conduct thing, which I guess it's all about interpretation in regards to it. But I did not allow her to do it. I

wasn't like I said hey, go in there and do this that and another. If you refer to the picture, it's not like I took the picture, it's a picture that she took of herself.

Chief Hines: Were those photos taken inside of your apartment?

Lt. Kelly: Yes sir.

Chief Hines: With firearms that belong to you?

Lt. Kelly: Yes sir.

Chief Hines: Did you have a sexual relationship with this defendant and the defendant's name is

Stafford?

Lt. Kelly: Yes sir, that's her name. Chief Hines: What's her first name?

Lt. Kelly: Bridgett

Chief Hines: Bridgett Stafford, which was the person mentioned in this case?

Lt. Kelly: Correct

Chief Hines: Did you have a sexual relationship with her while this homicide case was going on?

Lt. Kelly: There was sexual contact between me and her, yes sir.

Chief Hines: I will probably come back to this question again. Did this suspect or defendant travel out of town with you during the investigation of this homicide?

Lt. Kelly: She did travel out of town with me, yes sir. It wasn't in relationship to that particular case, it was in relationship to another case; but she did travel in the city vehicle with me.

Chief Hines: So how did you assist with helping her?

Lt. Kelly: When she saw me in court and told me she wanted to try to get together she told me and explained to me what her living and family situation was and I told her that I would assist. The first thing that I did was when after we talked on the phone a couple of times, I had her to meet me back down at 201 Poplar. Because she explained that she had a history years ago of taking pills and that she didn't anymore but that she still regularly smoked weed. So I said well look, what you need to do is this, you need to be able to show and tell people what you trying to do, what you need to do to rehabilitate yourself. So I took her down and had her to meet me at 201 Poplar. I know Judge Dwyer, but not a personal level but I know him very well from years ago, all the drug busts I used to make. Me and him developed a really nice relationship what have you. I knew that he ran this drug court and said this is what we are going to do. We are going to go down there and I'm going to introduce you to Judge Dwyer in the drug court and we're going to see what programs they have to offer that you can enter into or go from to so you can be able to say I did this, I completed this. She agreed we went down there I introduced her to Judge Dwyer, we spoke. Judge Dwyer offered some suggestions and some things that she could do. Because she did not have an active case in his court room, he could not directly speak on behalf. Normally how I think it works over there, you get paperwork, you complete this everything is good. But what he did he had his secretary to call around to a couple of places and got the information from some facilities and programs and provided that to me and to her. For her to contact these people on her own and for her to do that. Her living situation was that she was back and forth between her mother's home who she said she did not regularly get along with and that the home she shared with another a girl that was basically from right around the corner and that she was in the middle of and was trying to keep that up with or what have you. She said there were no job opportunities up there. So me and her started discussing so we'll start trying to find you a job. And so I would say you need to register to go back to school. From what she told me she had started the process to enroll back into school and I sat and directed her to places to try and get jobs so that she would start getting an income that would help her to be able to provide a place. Through the conversations that I had with her, it became clear that, she's from Tipton County that were no jobs in Tipton County that were to be had that she could get back and forth to because she did not have a working vehicle. She had one that she was trying to work on.

Chief Hines: The case that was in question that's being investigated, me homicide occurred the last of July 2017?

Lt. Kelly: Yes sir, I believe I think that's about right.

Chief Hines: Have that case gone to court and been prosecuted? Or is that still a pending case?

Lt. Kelly: Yes sir, it's still a pending case.

Chief Hines When did you start having a relationship with Ms. Stafford?

If I can break it down into 2 categories. I didn't come into physical contact with her until

Chief Hines: When was she brought in as a witness?

Lt. Kelly: She was brought in and I took a statement from her April 27, 2018.

Chief Hines: April 27, 2018.

Lt. Kelly: Yes sir. It was several weeks after that when I came back in contact with her down there at 201 Poplar.

Chief Hines: Was there any personal relationships established at that point?

Lt. Kelly: Aside from me and her talking about this is what you need to do to try to get yourself on a better footing. She has 3 children so that was the extent of the conversation.

Chief Hines: What was the next contact?

Lt. Kelly: The next contact with her? I would say a week. I spoke to her on the phone several times. But as far as physically actually...

Chief Hines: When you spoke her was she in jail or was she free?

Lt. Kelly: She was out of jail.

Chief: Ok.

Lt. Kelly: She was out of jail when I spoke to her, we spoke on the phone, I'd say a day or 2 later. Chief Hines: Ok so let's go from April 27, 2018 (first contact), when was a relationship or a sexual relationship established?

Lt. Kelly: The first time that was some sexual contact between me and her was when the trip to Montgomery occurred.

Chief Hines: I have the dates on here, but do you recall? At least a month?

Lt. Kelly: August? July, end of July, August somewhere around there.

Chief Hines: Of '17? Correction, of '18?

Lt. Kelly: Yes sir. When I first laid eyes on her was April 27, so yes that's about right.

Chief Hines: Ok, so about August or September of '18, she road to Montgomery, Alabama with you? Lt. Kelly: Yes sir. The way that she ended up, the way that came about, again she was back and forth, she had a vehicle that she was trying to get fixed and dealing with her mother and her living situation. By that point she was being told that she was getting ready to be evicted out of where she was living with this other person and I had actually given her money to get her car fixed and I had given her money for small things like she said she needed to eat, she needed to get something for her kids or whatever and I provided or sent her money for that through a web based app.

And I took sympathy on her, I had invested some time with her and wanted her to have a level of comfort and I truly did not want to see the girl out on the streets. And so I told her look, I've got to go do this, I said come ride with me and when we come back we'll get her living situation figured out. So that's how she ended up on the trip with me.

Chief Hines: Then somewhere along this trip a sexual relationship established, right? Lt. Kelly: Yes, sir there was some sexual contact. Yes sir.

Chief Hines: So what you're saying DR-104 Personal Conduct... was Personal Conduct violated? Lt. Kelly: There was a violation of Personal Conduct, yes sir. But again not to the imp degree that it is

Chief Hines: Since your relationship with the defendant you charged in a case?

· Lt. Kelly: That did occur sir.

Chief Hines: Photos inside your residence with several firearms?

Lt. Kelly: That was done and yes sir that did occur. But that again was done unbeknownst to me.

The accessory after the fact charge is a felony; but it was something that is a common practice that occurs and goes on between the homicide bureau and the prosecutor's office to get people to come in. You could speak with Jose Leon, you could speak with Reggie Henderson, and Karen Cook is the other prosecutor in regards to it and they will tell you that often time they are people that get that charge and it is an arm twisting tactic because it is so difficult to get people to come in on cases, so if we can finagle and getting that charge placed then what it does it basically is used through the prosecutor's office to force people to testify, which is what went on in this particular case. I would often use this as to offer an explanation as to why she was even arrested in relationship to that particular charge. I'd ask you to speak with Karen Cook, Jose Leon or any one of those prosecutor's and ask them, in homicide cases do these people even generally get prosecuted in regards to ... because what they do is they will hold the accessory charge over them and say you guys come to court and as long as you testify truthfully in regards to whatever their statement was then we dismiss those charges. That is something that is through and in conjunction all the time, it's a sad fact and if you work in Investigations and especially in that homicide bureau, you call down there and ask Tony Mullins or anybody who has been there any extended period of time and

Chief Hines: So that's why she was arrested?

Lt. Kelly: Yes sir.

Chief Hines: So let's talk about the compromising of the case of the codefendants, this person was used as a witness against the codefendants and you end up having a sexual relationship with this person who was supposed to testify against the codefendants.... do not feel that this would not compromise the

Lt. Kelly: Yes sir, I would tell you on the surface it would.

Chief Hines: Or potentially damage this case against those codefendants?

Lt. Kelly: I would say that again reading it like that would...when that particular case unfolded that girl was truly a witness. The sexual relationship that occurred, it's not a good look for me... Chief Hines: As the primary investigator of the homicide case against the codefendants Lt. Kelly: Yes sir

Chief Hines: Yes or no. Do you feel that your actions here potentially compromised a criminal case? Lt. Kelly: Yes sir, there can be perceived a potential compromise, yes sir. Chief Hines: I wasn't clear on this Michael S. McGee in this codefendant piece. Can you elaborate on him a little bit?

· Lt. Kelly: He was another person that was truly a witness, did not participate actively in the homicide, an accessory warrant was issued.

Chief Hines: I have an Eric Curry (primary suspect)?

Lt. Kelly: Eric Curry and Nicholas W. are codefendants in the homicide.

Going back to the Personal Conduct

Chief Hines: Did Ms. Stafford also accompany you on a trip to Dallas, Texas?

Lt. Kelly: Negative

DR-108 Truthfulness

In your statement to ISB you stated you did not buy or provide marijuana to the defendant. You also stated you did not refer her to anyone to purchase marijuana. In text messages you sent to defendant, you give the name and address of a person for the defendant to meet and purchase marijuana (as in the IAB statement). You tell the defendant you will get her some green. You were also deceitful in telling the investigators the defendant would be used as a witness in a murder case. You allowed the defendant and another investigator to travel with you on a City of Memphis sponsored out of town trip. You advised that the defendant slept in your hotel room but in separate beds. The defendant refuted that statement and advised that it was only one bed and you shared with her. This places you in violation of Memphis Police Department DR- 108 Truthfulness which reads: A member shall not give any information, either oral or written, in connection with any assignment or investigation that is either knowingly incorrect, false, or deceitful.

Chief Hines: You told them (ISB) that the individual went to Montgomery, Alabama with you and it was 2 beds in the bedroom. So, that's what you told them.

Chief Hines: Is that true or false?

Lt. Kelly: I did not lie to them. That's why I'm trying to figure out how that can be Truthfulness. I had told them in the statement.

This Hearing will be continued until November 8, 2019 at 1:00PM.

Lt. Eric Kelly 4679, abruptly retired on November 8, 2019, prior to the continuation of his Hearing dated for November 8, 2019 at 1:00PM. This Hearing will now be held in **ABEYANCE**. No further actions will be taken at this time.

Sheila Green, although not the driver of the City Of Memphis vehicle, which was stopped lawfully for a traffic violation, but Sgt. Green was a passenger in the vehicle on official business for the City Of Memphis Police department. DR 127 Reporting Improper Conduct specifically states: "A member shall immediately report to the Department any violation of Policies and Regulations or any other improper conduct which is contrary to the policy, order, or directives of the Department."

When Sgt. Eric Kelly was stopped by a Law Enforcement in Alabama for speeding and given a citation, this information should have been immediately reported to Sgt. Kelly and Sgt. Green Supervisors. At the very least a memo should have been written by both Sgt. Kelly and Sgt. Green immediately notifying their supervisors of the encounter.

This traffic violation was never reported to a supervisor until a case was opened against Sgt. Kelly in another matter. Sgt green appeared to bear no responsibility in Sgt. III) Allegation:

It is alleged that Lieutenant Eric Kelly, when he was a Homicide Sergeant, was engaged in an inappropriate relationship with a female co-defendant who he formally charged with Accessory After the Fact: to wit: 1st Degree Murder.

IV) Background:

On March 1, 2018, Sgt. Eric Kelly issued a warrant for the arrest of Bridgett Stafford (29 yoa), for Accessory After the Fact: to wit: 1st Degree Murder. On December 13, 2018, during a proffer session with the Federal Bureau of Investigation (FBI), Bridgett Stafford's boyfriend, Jeffrey Meadows, advised Sgt. Kelly had leveraged the criminal charge against Stafford to initiate a sexual relationship with her.

On May 2, 2019, an administrative investigation was opened to determine if Lt. Kelly violated any policies or procedures of the Memphis Police Department relative to his relationship with Bridgett Stafford.

VI) Evidentiary Findings:

A) Statements:

Civilian Witness Bridgett Stafford, stated she was arrested for Accessory to First Degree Murder around May or June of 2018. She was interrogated by Sgt. Kelly. When Sgt. Kelly walked into the room the first thing he said was, "I will fuck the shit out of you." During the interrogation Sgt. Kelly asked her if she was a stripper and did she sell pussy. Sgt. Kelly gave her his business card and told her to call him.

Stafford called Sgt. Kelly after her court appearance and they began a relationship which involved sexual intercourse. Sgt. Kelly never made any promises or threats dealing with her criminal charges. The relationship evolved to the point where Stafford had the codes to get into Sgt. Kelly's apartment and she would stay overnight four to five days a week. She was left alone in his apartment and had access to his guns. She photographed herself with the guns with Kelly's knowledge.

Stafford went with Sgt. Kelly and another female detective on a work related trip to Alabama. Stafford and Kelly picked the detective up at the detective's house. Stafford was introduced to the detective's wife and they smoked weed together before the trip. The officers did not smoke marijuana. They were stopped by a trooper in Alabama for speeding. She was nervous because she had marijuana on her that Kelly provided,

Kelly provided her with over \$2000 during the course of their relationship. She got a job as a stripper at the Gold Club and he bought her outfits and other items she needed. She went with him to buy marijuana from a male black several times. He also would provide marijuana to her when she spent the night at his residence. She stated he would put the marijuana in a McDonald's bag. Stafford is a member of the Gangster Disciples gang.

Citizen Witness Mark Jones stated to ISB investigators he and Eric Kelly are childhood friends. They grew up together in Orange Mound. He has not talked to Kelly since his mother died several months ago.

Witness Officer Sgt. Fausto Frias stated he participated in the interrogation of Bridgett Stafford. He did not hear Lt. Kelly say anything inappropriate to Ms. Kelly before, during or after the interview. He has not seen Ms. Stafford at Lt. Kelly's residence.

Witness Officer Sgt. Sheila Green confirmed she went on a work related trip to Montgomery, Alabama with Lt. Kelly on August 28th. She stated a female civilian was in the vehicle when Lt. Kelly picked her up from her house. She did not know the race of the female. The only physical characteristics she remembered were her being light skinned and shorter than her.

She did not have any interactions with the female. Sgt. Green and Lt. Kelly stayed in separate rooms at the Holiday Inn. Lt. Kelly drove the vehicle the entire trip. During

the trip they were involved in a traffic stop. She did not know whether he was issued a citation or a warning.

In her follow-up interview Witness Officer Sgt. Sheila Green stated a civilian female went on a trip with Lt. Kelly and her to Montgomery, Alabama. She could not remember her name but she was with Lt. Kelly and not her. She did not receive permission to allow a civilian to go on the trip and no one went with her. Lt. Kelly introduced the female but Sgt. Green could not remember her name. Sgt. Green and Lt. Kelly had separate rooms at the Holiday Inn. Sgt. Green was unsure if the female stayed in Lt. Kelly's room.

Sgt. Green got reimbursed for meals she purchased. Lt. Kelly and her paid for their meals separately. Her receipt reflected two guests purchased meals but she explained she ordered two entrees. Lt. Kelly was stopped for speeding during the trip and was issued either a courtesy or speeding citation. Sgt. Green was presented a Photo Lineup of six (6) Caucasian females. She identified Photo #2 as the female that went on the trip to Montgomery, Alabama with Lt. Kelly. (Photo #2 Bridgett Stafford)

Principal Officer Lt. Eric Kelly stated he was the case investigator in the murder investigation of victim, Robert Glidden. He issued an Accessory After the Fact: to wit 1st Degree Murder warrant on Bridgett Stafford related to the murder investigation. Stafford was arrested on the warrant and he questioned her along with Sgt. Frias. During the interview he talked to Stafford about the case and her life choices but he did not say anything inappropriate. Stafford was a high ranking "GD" and Kelly gave her his card with his work phone number () and told her to call him if she wanted help to change her life.

A friendship was developed between them and he gave her his personal phone number. He introduced her to several associates that could help her obtain employment. Stafford stayed overnight at Kelly's residence multiple times. Kelly acknowledged pictures of Stafford in his apartment posing with his firearms and pictures of them together. Their relationship involved oral sex and not intercourse.

Stafford decided she wanted to become a dancer to make money. Kelly supported her decision but did not force her. Kelly bought her outfits and accessories for her job at the Gold Club as a stripper. In totality he gave Stafford thousands of dollars in person or by Cash App throughout their relationship. Kelly did not provide Stafford with marijuana nor did he refer her to anyone to buy marijuana.

Stafford went with Kelly and Sgt. Green on a work related trip to Montgomery, Alabama. Kelly and Stafford shared a hotel room with two beds. He did not spend any stipend money on Stafford. On the way back to Memphis he was stopped in Alabama on Interstate 72 or 78 by a State Trooper for Speeding. He took a driving class in Memphis so the ticket could be reduced from \$327. He did not inform his Supervisors that a civilian went on the trip. He also did not formally inform his Supervisors that he got a ticket.

VIII) Analysis:

Lt. Eric Kelly

The primary issue related to this investigation centers upon the actions of Lt. Eric Kelly and whether his actions transcend the standards of the Memphis Police Department. These standards are established in the Memphis Police Department's **DR-104 Personal Conduct**, which states:

DR 104 Personal Conduct

The conduct of each member, both on and off-duty, is expected to be such that it will not reflect adversely on other members, the Department, the City of Memphis, or the law enforcement profession. This regulation applies to both the professional and private conduct of all members. It includes not only all unlawful acts by members but also acts which, although not unlawful in themselves, would violate either the Law Enforcement or Civilian Code of Ethics, and would degrade or bring disrespect upon the member or the Department.

Law Enforcement Code of Ethics states in part:

I recognize the badge of my office as a symbol of public faith, and accept it as a public trust to be held so long as I am true to the ethics of the police service. I will constantly strive to achieve these objectives and ideals, dedicating myself before God to my chosen profession ... law enforcement."

The public demands that the integrity of its law enforcement officers be above reproach, and the dishonesty of a single officer may impair public confidence and cast suspicion and disrespect upon the entire Department. Succumbing to even minor temptation can be the genesis, which will ultimately destroy an individual's effectiveness and contribute to the corruption of countless others. A member must scrupulously avoid any conduct, which might compromise the integrity of themselves, their fellow members or the Department.

It is essential that public confidence be maintained in the ability of the Department to investigate and properly dispose of complaints against its members. Additionally, the Department has the responsibility to seek out and discipline those whose conduct discredits the Department or impairs its effective operation. The rights of the member, as well as those of the public, must be conducted fairly, impartially and efficiently, with the truth as its primary objective."

The administrative investigation revealed Probationary Lt. Kelly entered into a sexual relationship with a female co-defendant, Bridgett Stafford, which lasted approximately eight (8) to nine (9) months. The homicide investigation began in July 2017, where Stafford was developed and later arrested on April 26, 2018. Lt. Kelly was the lead investigator who conducted her interrogation. According to Stafford, at a court appearance, Kelly saved his personal cell number in her phone as, "Dirty Red Nice Ass 2". This investigation did not show Kelly made any promises or threats concerning her criminal case; however Kelly's involvement in their relationship became unethical in nature.

A forensic examination of Stafford's cell phone conducted by the FBI revealed text messages from Kelly arranging for Stafford to get marijuana from a third party, "Call my guy mark ...I'm gone tell him ur call...and u have to stop sharing ur weed mama..what I get for u...I get so YOU can enjoy it". In another text message exchange he tells Stafford, "I will get you some green". Photo log page 3, 4

In his statement to ISB investigators Kelly acknowledged Stafford being a "high ranking GD" (Gangster Disciples) gang member and having an extensive criminal history.

According to both Kelly and Stafford she would stay overnight at Kelly's residence. The forensic examination of her phone also showed several different photographs of Stafford and Kelly together, once at a gun range and another one as a selfie where Kelly is driving and Stafford is on the passenger side seated in a vehicle.

Some text messages were explicit in nature, Kelly to Stafford, "Get nasty for me mama...let me see it all...I want to jack off so damn bad right now" Photo log page 8

Kelly also sent Stafford a nude photo of his genitalia. Photo log page 10.

Kelly provided Stafford with over two thousand dollars during the course of their relationship. He acknowledged in his statement to ISB the money was for clothing, accessories for her job as a stripper at The Gold Club, to buy marijuana, pay utilities and gifts.

The homicide detective's role is being the voice of a murder victim. Kelly's official sole purpose and focus should have been ensuring that justice would prevail. Instead he began an unethical relationship with the suspect he arrested in the investigation. His behavior has potentially jeopardized the on-going legal proceedings against the suspect and her codefendants. The actions of Kelly have also alarmed the District Attorney's office. His current and upcoming cases are now stained with the stench of corruption. This is a direct violation of Memphis Police Department's DR 304 Compromising Criminal Cases, which states:

DR 304 Compromising Criminal Cases

A member shall not make any promises or arrangements with prisoners or between a suspect and his victim intended to permit the offender to escape the full penalty provided by law, or interfere with the courts, or for personal gain or benefit, use their official position to make any arrangements for any suspect or prisoner to escape prosecution.

A secondary issue related to this investigation centers upon the actions of Lt. Eric Kelly and whether his actions transcend the standards of the Memphis Police Department. These standards are established in the Memphis Police Department's **DR-108 Truthfulness**, which states:

DR 108 Truthfulness

A member shall not give any information, either oral or written, in connection with any assignment or investigation that is either knowingly incorrect, false, or deceitful.

In his statement to ISB investigators, Kelly stated he did not provide marijuana to Stafford. He also stated he did not refer her to anyone to buy marijuana. In his text message exchanges with Stafford he clearly indicates his intent. Photo log page 2, 3, 4

Stafford was adamant in her statement to investigators that Kelly provided her with marijuana on numerous occasions.

- She explained Kelly would bring her marijuana in a McDonald's bag when she would be at his apartment.
- She went with Kelly to pick up marijuana from one of Kelly's male friends.
- Before they went out of town together, Kelly brought her marijuana to take on the trip. Before they left he was present when she smoked it.

In his statement to investigators Kelly spent a considerable amount of time attempting to minimize the seriousness of Kelly's charge. He was intentionally deceitful when he stated prosecutors would use Stafford as a witness in the case. Stafford stated to investigators she had not been contacted by the prosecutor's office and was still a defendant in the murder case.

A third issue related to this investigation centers upon the actions of Lt. Eric Kelly and whether his actions transcend the standards of the Memphis Police Department. These standards are established in the Memphis Police Department's DR-608 Accessing Reports & Records with No Legitimate Purpose which states:

DR 608 Accessing Reports & Records with No Legitimate Purpose

A member shall not access official offense reports, departmental records or information concerning police matters without a legitimate law enforcement purpose.

Stafford informed Kelly she had a warrant in Haywood County. Kelly asked for her date of birth, social security number and driver license number. Kelly informed Stafford, "I don't see nothing" and "u have a suspended license..that's all I see..." Photo Log page 27, 28

According to Kelly's Memphis Police Department Watson Report Audit, he queried Stafford on December 12, 2018, at 11:08 pm, 11:09 pm, 11:20 pm and 11:21 pm. He advised in his statement to ISB investigators that he did this for personal reasons which is a direct violation of the policy.

The next issue related to this investigation centers upon the actions of Lt. Eric Kelly and whether his actions transcend the standards of the Memphis Police Department. These standards are established in the Memphis Police Department's **DR-903 Unauthorized Passengers**, which states in part:

DR 903 Unauthorized Passengers

A member shall not allow unauthorized passengers to ride in any vehicle of this Department, unless specifically authorized by competent authority and in compliance with Department orders and directives.

In his statement to investigators, Kelly admitted on August 28, 2018, Stafford rode with him in a city issued vehicle to Montgomery, Alabama on a work related trip. Kelly advised he did not receive permission from his supervisor to allow Stafford to travel on the trip.

The next issue related to this investigation centers upon the actions of Lt. Eric Kelly and whether his actions transcend the standards of the Memphis Police Department. These standards are established in the Memphis Police Department's **DR-125 Member Under Investigation**, which states:

DR 125 Member Under Investigation

A member shall immediately submit a written memo to their supervisor/commanding officer that they are under investigation by any law enforcement agency, or any regulatory agency. A member shall immediately submit a written memo to their supervisor/commanding officer that they have been issued a misdemeanor citation or citation for any misdemeanor offense (including traffic citations while off-duty), arrested for any misdemeanor/felony offense or is being sued in a court of law.

In his statement to ISB investigators, Kelly advised he was issued a citation for speeding in Alabama by a trooper on the way back to Memphis from Alabama. Upon returning to Memphis he did not inform his supervisor in a written memo that he was issued a citation.

The final issue related to this investigation centers upon the actions of Lt. Eric Kelly and whether his actions transcend the standards of the Memphis Police Department. These standards are established in the Memphis Police Department's DR-110 Consorting with Persons of Bad or Criminal Reputation, which states:

DR 110 Consorting With Persons of Bad or Criminal Reputation

A member of this department shall not knowingly socialize or have a business relationship with another person, who has been imprisoned or convicted of a felony, or who are known criminals, except in the performance of their official police duties.

Prior to being arrested for, Accessory after the Fact to wit: First Degree Murder, for which Kelly charged her, Stafford had been arrested a total of ten (10) times. Her charges range from Possession of a Controlled Substance, Driving Offenses, Shoplifting, Drug Paraphernalia to Underage Drinking. Her adult criminal history started in the year 2009 and has even continued since her arrest in the murder investigation. She was arrested September 7, 2018, again for Shoplifting. Kelly advised ISB investigators he was aware of her criminal history and gang affiliation. He stated police in her county were aware of her criminal history, yet he engaged in a relationship with a known criminal gang member.

During the investigation it was revealed Stafford traveled on a work related overnight trip to Montgomery, Alabama with Sgt. Green and Lt. Kelly. Stafford was not authorized by the City of Memphis to attend the trip. Stafford also stayed the night in Kelly's hotel room which was rented by the City of Memphis. Sgt. Green admitted in her statement she did not report these facts to anyone of her supervisors. Green was also traveling with Lt. Kelly when he received a traffic citation in Alabama. She also chose to not report the improper conduct of speeding in a city vehicle to a supervisor. This is a violation of

Memphis Police Department's DR 127 Reporting Improper Conduct which states:

DR 127 Reporting Improper Conduct

A member shall immediately report to the Department any violation of Policies and Regulations or any other improper conduct which is contrary to the policy, order, or directives of the Department.

Based on the facts of the case, the preponderance of evidence shows that, Lt. Eric Kelly #4679 IS in violation of the stated allegation, DR-104 Personal Conduct. Therefore the allegation is SUSTAINED.

Based on the facts of the case, the preponderance of evidence shows that, Lt. Eric Kelly #4679 IS in violation of the stated allegation, DR-304 Compromising Criminal Cases. Therefore the allegation is SUSTAINED.

Based on the facts of the case, the preponderance of evidence shows that, Lt. Eric Kelly #4679 IS in violation of the stated allegation, DR-108 Truthfulness. Therefore the allegation is SUSTAINED.

Based on the facts of the case, the preponderance of evidence shows that, Lt. Eric Kelly #4679 IS in violation of the stated allegation, DR-608 Accessing Reports & Records with No Legitimate Purpose. Therefore the allegation is SUSTAINED.

Uh, the investigation, uh, led us, um, it ultimately resulted in locating several people who had either witnessed or, or participated on one way, on one level or another, uh, uh, in the homicide. So it required us to take statements and this, that and the other. We, uh, ultimately charged, uh, uh, the main people involved with it. And then there was some people who saw stuff, uh, that, um, that we were trying track down. And, um, there was people that, um, we also issued warrants, uh, for, uh, accessory after the fact.

Q: Now who was charged in that investigation?

A: Eric Curry and...oh, I cannot think of the other, uh, name, dude's name, uh, but it was another male, uh, white. I cannot think of his name off the top of my head right now. Uh, they were charged with, uh, his, his homicide.

O: Okay, you, um, mentioned accessory.

A: Yes sir.

Q: Who was charged with accessory?

A: We issued, or I issued, uh, ultimately issued warrants on people for, uh, accessory because of a, during the course of the investigation, they were supposedly present and witnessed certain things, uh, and the, the fact of the matter is that, uh, the accessory after the fact charge was a, truly a thin charge, uh, but there was enough, I was able to articulate enough to get the warrants issued based off of statements that had been taken from people that were there after getting, uh, certain people identified and stuff and were, were able to get the warrants issued. But really it was more of, uh, a ploy to get people in to make the case more solid. The people who were, uh, actually issued, uh, uh, the accessory warrants, if you look at their statements, they actually gave more witness statement, uh, statements in regards to it and they were being treated as far as I know by the prosecution as, as witnesses in the particular matter.

Q: So who did you charge with accessory after the fact?

A: Uh, Bridgette Stafford and, uh, there was another male, um, whose name escapes -- Michael McGehee.

A: Um, one of the, one of the witnesses involved had-had said that they were, uh, there was, there was some females in the room, uh, who could verify some comings and goings. They did not see the murder occur, um, but they could verify certain stuff that the witness had said. So again, back to my making, making, uh, the stuff done, uh, making the case more solid, so. Uh, also the witnesses had advised that the people that were in this room had, uh, taken possession of the, the victims cards and had supposedly, uh, um, used them to purchase some stuff. So I did some, some following up and was to, to track some stuff down. And based off of what the witness said and stuff that I was able to gather and was able to identify, uh, uh, two people for sure. I wanna say -- yeah, it was just those two people that I was able to positively identify.

O: So was Bridgette Stafford ever arrested?

A: Ultimately, uh, the-the-the progression of what happened was once I identified her, I actually, uh, tried to make contact through, uh, to her because, again, the warrant was really thin, uh, as far as actually charging them with-with a true accessory after the fact, you know. Truly accessory after the fact is someone knowingly and willingly participates in something or what have you to get, um, uh, to-- and-and-- Like if somebody gets killed, like if me and, me and uh. Ms. Cage are here and we kill you and he's sitting right there and he knows that we killed you and then I go through your pockets and I, and I take your credit card and and he, and then I take that credit card and pass it to, to him, he knows that we killed you and get away. On this particular case, that's what happened. A man was killed. These people didn't see the killing, they didn't see a body or anything, the people I charged with accessory, but they were in a room where the suspects were. So I needed to get with them to talk to them to, to get a statement from them. Truly wanted to treat them as, have them as witnesses, that was the ultimate thing. And ultimately, um, I made contact with, um, the mother of Ms. Stafford and advised who I was --"Look, I need to speak with her about this case. She's not in any trouble, but I really need to talk to her. But I-- but it can go, uh, further, but I really don't want it to." -- was the exact conversation. I-- Then I also contact Tipton County Sheriff's Department and, and inquired with them about her. They were really familiar with her because she, from past records. They go and attempt to try to locate her, um, and uh had negative results and stuff. So after several months of back and forth, calling up there, advising, "Hey, just tell her to come down and give a statement," this, that and the other, uh, ultimately I was able to, uh, creatively articulate enough PC to issue a warrant. It was-- but the, the PC was thin, but I was again able to creatively articulate.

A: Uh, research in-in, in WASP, uh, and located a phone number.

Q: So you interviewed her. You, you know, you know when that was, the date?

A: I don't remember a date. Uh, if you look at her, if we're able to a hold of the case file, the date that the statement was taken would be on her, on her statement.

Q: Okay. Um, who did you question her with? You did say you interviewed her. Who'd you interview her with?

A: Yes sir. Uh, I wanna say it was, uh, he was detective then, but now he's Sergeant Frias. I believe he was the one -- he typically goes, uh, helps me with the interviews.

Uh, ultimately we go back in with a Advice of Rights form and several photospreads and-and, um, and other stuff-stuff related to the homicide case and-and what have you. My spill that I typically go with people is, uh, I pride myself on, uh, being straight up with people and letting them make their own decisions one which way they go. So I, I explained to her, uh, that I had been, been making several efforts to, to get in touch with her and what have you and that I really didn't wanna have to put the warrant out on her, but I needed to get her in here, uh, and that she had been charged with Accessory because I could prove on a certain level that she, um, uh, had possibly spent, used his credit card along with some other people. Uh, she didn't go in and swipe or do or this. that and the other -- cus like I said, I-I got creative with, with the PC for the warrant. I got creuh, and basically told her this, this, this something that you can be charged with, you can go court on it. But I said, "What I need you for is, is to be honest with me, tell me what you saw." I told her, I said, "I don't think that you killed or played a hand on a particular person, but I need to, you to tell me what you, what you know." And she, uh, was a little bit apprehensive and stuff. Uh, she's very street savvy, uh, and paranoid, uh, based off of my interaction--uh--actions with her and stuff. And ultimately, uh, Advice of Rights was given, she signed it, she said she wanted to talk, she said she was gonna be honest, and she was for the most part. I think she was for the most part honest with, with, uh -- she told me what I expected her to tell me.

Q: That was your first contact with her? A: Yes sir.

Q: Now specifically during the interview, did you state to her, uh, that you would fuck the shit out of her and, uh, during the interview did you ask her did she sell pussy?

A: No. No. Never, um...we-we interviewed her about the case, we talked about her personal life and what she was going on, was going through. Um, uh, um... I, I mentioned to her and told her, I was like, "I'm gone give you a card." I said, "I'ma gi--" uh, "If you," I said, "if you-- You don't seem like you're a bad person, but you're running around. You-You're a female that's a high-ranking GD." I said, "You know gangsters and associate with people that I've put in jail on-on charges and stuff." And I said, "It-It makes no sense," I said, you know, "If-If you have an

issue--" I said, "With you having that stuff looming o-o-over you," um, I said, "what you need to do is you need to try to get yourself together, you need to go back to school, you need to get you a job, and then what happens is when-when this goes to court, if they use you as a witness, you will be-- you can sit on the stand and be able to say, 'Okay, this is what I'm doing with my life." But never did I ever during an interview of any type say that 'I'll fuck the shit out you' at, at that particular time.

Q: Did you, you said you gave her a card. What number, what's on the card? What-What's on the card?

A: Uh, the, it would've been the, uh, the uh City, uh...I wanna say I had c-- yeah, I had the card, it had the, uh, City of Memphis, uh, phone number.

Q: What phone number was that?

Q: Was any personal information exchanged during or after the interview?

A: No, I t-- I told her if y-- if you needed some help or wanted some guidance or whatever, I told her, I said, "You feel free to call back up here." I said, "I talk to people I've put in jail all the time, they call up here." I said, "But if you're trying do something -- y-you say you wanna do this" -- she had some kids that-that she, uh, was very proud of and stuff, and I said, "Well, with the rate you're going, you're gonna be on the bad end of this." I said, "If you want some help," I said, "you can contact me and I'll help you as best I can."

Q: But you knew at that first interview she was a, uh, she's an active Gangster Disciple? A: During the c-- well, I just, uh, assumed that from what I could see on her page, on her Facebook page.

Q: Okay.

A: Uh, and after interviewing, she-she freely admits that-that she was a gang member.

Q: Okay, cool. Thanks, I didn't, I didn't realize she was active.

A: Mm.

Q: Did you give her your personal phone number?

A: Ultimately when, when uh she-she contacted me, we d-- we developed a, uh, a relationship, uh, that, uh, evolved into where I, uh, did give her, uh, a personal phone number and told her to--

Q: What phone number was that?

A:

Q: After the interview, did you see, did you see her again and when?

A: Yes sir. Uh, she ultimately ended up contacting, uh, me. We spoke on the phone. Uh, talked to her, uh, a-a-about her life -- she was telling me what she wanted to do and what she was trying to do, but she was having difficulty doing it because she didn't have a job, her and her mother didn't get along, didn't have a place for the kids, didn't have a vehicle, blah-blah, all that stuff. I said, "Okay. I'll tell you what I'm gonna do in this particular situation." Uh, I said, "I'm-I'm

gonna assist you, uh, a-as best I can with it." I-I said, "If you show me that you are trying to do something with yourself, I will go above and beyond with, with assisting your way." I said. So one of the first things that I did was she, um, had a court appearance on something unrelated to, uh, the Accessory charge. Uh, she was at court with somebody at 201 Poplar and stuff. I saw her and spoke with her and-and, um, and uh I said, "Look," I said-- then I point to a courtroom, I said. "You," I said, "You-You, You, uh, for you-you..." -- she smoked weed and-and, uh, possibly did pills and stuff. I said, "If you got a drug problem," I said, "this court right here," I said, "I know this judge," and it was Judge Dwyer's courtroom. I said, "Well, come down here. I'll take you and I'ma introduce you to this man and see what programs they have available for you." I said. "I think the way that his court works is that you actually have to have a charge in there." I said, "But I know this man." I said, "Every time he sees me we speak and I used to go in the courtroom all the time from when I used to deal with street stuff." I said, "He's a great dude." So ultimately -- I don't know if it was that day or another day -- we were down there and I introduced her to him, they shake hands, uh, and he talks to me and he tell me kinda what I already knew, was that if she wasn't active, didn't have an active case, that he couldn't directly do-- but he recommended somewhere for her to-to go. Take the information, I give it to her and stuff and I said, "Look, you need to go--" I said, "This-- you're, you're--" He had his secretary call over to the place to do whatever it is they do and the thing." I said, "Okay, so here's the start of this. You-You-You do this," and what have you. She didn't have a job. I had her, uh. to, uh. my-my-- I work a lot, I don't have an opportunity to-to, uh, clean, uh, my place as much as I do. so I said, "Look this what I'll do. Q: Did y'all ever attempt to have sexual intercourse?

A: The-There was, there was talk, uh, and whatever you would-- There-There was, th-there was no con-- no.

Q: There was never anything physical? Did you--

A: No sir.

O: What about a kiss? Anything?

A: No. No. She-She had spent the night at-at my, uh, um, uh, apartment before and-and I'm ultimately get to it and what have you. She-- at-at-at one point I lost communications with her --I stopped talking to her, she, uh, stopped texting me -- and several months later, ended up, she ended up getting back in contact with me, homeless, didn't have a place to go, and this was right the day that me and, and, uh, Sergeant Green were getting ready to go on a trip and she is boohooing, crying and saying that, saying that she needed a place to go. I did-- wasn't gonna leave her at my place alone, so I-I made a decision at that time and said, "Look, just come on and-I've got to go do this and get this taken care of, so come and go, uh, with-with me on this."

Q: But, she went with you where? You and Sergeant Green--A: It was to, uh, it was to, uh, Alabama -- I forget the exact city, but south of Birmingham. Uh, it

He's her mom's boyfriend's son and he's been, he...from-- We had a bunch of conversations and I wanna say she told me that he is the dude that she had told me about in the conversations that had forced himself on her when she was younger and he was, again, selling dope and he supposedly had active federal warrants and she needed help. I said, "Well this is what you can do." I said, "If you, if th-- if this is going on, call the police." She said, "They can't do that, he's gone kill me." I said, "Give me his name and his information." I said, "If he's got active--" She said, "I know the U.S. Marshalls are looking for him." I said, "Well, I know somebody on the U.S. Marshalls Task Force. If th-- if that's true..." I said, "If-If you tell me where you are, I'll contact them, they'll verify the information and boom, they got it." I said, y-you know, "The--I'll tell them to play you off like you don't know what, you know, they can call you all out your name, make you f-- make the situation look real." I contacted... Q: So during the course of your, you and her relationship, she did get a job at the Gold Club? A: Yes.

Q: And you're saying you didn't help her?

Q: Can you read it for me, Lieutenant Kelly?

A: Yes, I see it.

Q: Did you try to help her find any other type of employment?

A: Um, yes. Um...

Q: Lieutenant Kelly, is it illegal to buy or sell marijuana in the state of Tennessee?

O: Did you provide marijuana to Bridgette Stafford?

A: No sir.

O: Did you give her money to buy marijuana?

A: No sir. I gave her money, but wh-whatever she did with it, whatever, was, was, you know, her deal was. I knew that, uh, that, that she probably, uh, uh, did it because she-she would tell me, uh, what she was doing and, uh, I actually had a conversation with her where I told her that she needed to be doing better with the funds that I was giving her. That's the-- this girl, from what I could tell, uh, had a, not only the marijuana going on, but possibly something else. I never saw it myself, but again, that's why the, one of the first things I did was take her to Judge Dwyer.

Q: So did you ever refer her to someone who she can buy marijuana from?

The-The girl that—it's a couple of different conversations going on at, uh, at the same time and I'm addressing a couple of different things. Uh, but I'm not in business with-with Mark and even though the text reads as such, it is totally taken out, out of context. Uh, this "what I get for you" is ref— is in reference to, to her, the money that I give her for her outfits, which is why I asked her to send me a picture of her in her outfits.

A: "A warrant for what?" And I, I typed, uh, there's a typing -- "IDK." Uh, and then she says, "Give me..."--

O: Oh, no no.

A: Oh, oh okay.

Q: Yeah. Yeah.

A: Yeah.

O: Right here.

A: "I just got a call to some-something that I ha-- I just got a call today that I have a warrant, Haywood County."

O: That's her?

A: Yes, this is, that is her. "Fuck this shit. See how much you care. See how much you care."

O: And what did you reply?

A: Uh, I replied, "A warrant for what?" She replied, "IDK." I said, "Give me your DOB." "3/20/90." I said, "What's your SSN or your DL number?" Uh, what-what sh-- what she's referencing is she, uh, I actually ended up talking to her on the phone and she said that she had been stopped by the Tipton County, uh, Sheriff's Department. Again, this was during the time when I really minimal communications with her. She said she had been stopped and they advised her that she had a warrant. She asked me to, to, to check it and, uh, uh, I s-- I said, uh, I, I asked her for the information or what have you. I just looked in WASP because I knew that at some point, um, um, she had been arrested in Tipton County on a Shoplifting charge. I said, "Well, maybe Tipton County's getting something confused," so I looked to see if something was in, in WASP. Um, and ultimately I told her that what she needed to do-- She wanted me to call and I told her, "Ultimately, what you need to do is as simple as either go online and do it." And I said, "If you can't do that, call them and they will tell you."

Q: Now you're saying that you did check her in Watson?
A: No, no. Uh, what I'm saying is I-I, what I did was I, I pulled up her, her DOB and stuff. I didn't check it under the pretense of, of uh...

Q: But what I'm saying on December the 12th at 11:08, 11:09, 11:20, 21, you ran her in your Watson account.

A: Uh, I did.

O: Yes.

EK

A: Well, if-if I did again, if-if that's in conjunction with-- the thing, I was just checking to see-- I know that warrants from sh-- from Haywood County or Tipton County, which would not show up in the thing. I was just checking to see if they were, if-if-if she had warrants here or not.

O: So it wasn't in relation to the Accessory charge, it wasn't--A: Yes, yes.

O: So--

A: I thought this something had, I thought that maybe she missed a court date and that-thatthe prosecutors or something had-had, uh, gone and, and reissued or tryna get it back in.

Q: But the warrant, was this out of Haywood County?

A: What she was saying was that warrant was out of Haywood County. Again, I know that I can't check in Watson for anything in Haywood County. I was checking to see if, if something had happened in Shelby County.

Q: But you know, far as with the Accessory charge, it would have to be in Shelby County, not Haywood County. So if she told you Haywood County, you really wouldn't have a reason to check your Watson to see if Shelby County issued anything.

A: Well, a-again the-the-the thought process at the time was she's getting stopped in Tipton County and Tipton County is telling her that she has a warrant in Haywood County. I'm aware that she has a shoplifting mis-- she got a Misdemeanor citation in Tipton County for shoplifting. So I'm like-- well, I'm thinking to myself maybe they're getting that confused. And then also, thinking-- overthinking the situation, I'm like, well maybe something has, sh-she done caught another charge that she hadn't told me about because she caught the Shoplifting charge in-in Tipton County during the course of me interacting with her. So I'm thinking, uh, that, that, uh, I'm just gonna check to see, maybe they have something confused. And ultimately what I ended up telling her was that she needs to call Haywood County. "If they keep telling you..." -- cus I wanna say she got stopped, uh, or had an interaction up there two different times. And the-- and I had told her before, "If you think you have a warrant, call to Haywood County. They'll tell you." At least in Shelby County, I know that they will. And if you go back and if you read her texts, if you read the context of her, her, her text, she said, "See how much you..." -- she sends the information and says, "See how much you care." That was her, because I had not been communicating with her.

Q: Okay.

A: Uh...her way of I guess getting my attention and-and putting, laying the guilt trip on me to uh s-- uh, to see if she truly did have a warrant.

Q: Let's go back to this Alabama trip.

A: Yes sir.

Q: Uh, what did she do while you and Sergeant Green was conducting your police business? A: Uh, she stayed, uh, at the room.

O: Okay. You and her -- how many rooms did y'all have?

le

A: There were, there were two rooms -- Sergeant Green had a room and then, uh, me and her, uh, had a room with, uh, double beds.

Q: Did you get a stipend, uh, from the City or did you, uh, submit any receipts from, from, uh, the trip to get reimbursed for anything?

A: I believe I did, yes sir.

O: Did you pay for her meals with any...

A: Negative. Negative. If you, matter fact, if you-- if I remember that trip, the-the trip, it wasn't even to the, to the max or to the limit of what it could've been.

Q: Do you have a Facebook account, Lieutenant Kelly?

A: Yes sir.

Q: What's your, uh, username?

A: Uh, the one that I'm sure that you're probably referring to is the, the fake Facebook account that I, uh, created, uh, as part of an investigator using it as an investigative tool. Uh, it's T-R-A-N-uh-M-A-R-L-O-N.

Q: Okay, when you and, um, Bridgette Stafford stayed in the room together on the trip, it was, how many days did y'all stay?

A: This-- uh, I'm I remember correctly, it was one -- we drove down...we drove down...uh, did the...drove down... Okay, in this one I think we drove down, s-spent the night -- cus we left from Memphis and got down to Alabama -- we spent the night, did the interview the next day-

Q: Sorry, Lieutenant. I have your travel...

A: Thank you.

Q: ...paperwork right there.

A: I appreciate that. So this would've been, uh...

Q: What day y'all went down?

A: Uh...bruh, my eye-- my eyesight is terrible. 8/28. Okay, 8/28 and came back 8/29.

O: Okay, What vehicle did y'all drive?

A: It was a City of Memphis, uh...it was a '14 Dodge Durango.

Q: And you said you, she went down on the trip, you didn't receive any permission. Did you let anybody know when you got back that a civilian had went on the trip?

A: No sir, I did not, sir.

Q: Now, you stayed overnight. Um, so you're saying there no type of sexual relationship between you guys?

A: We talk -- I talk a good game cus that's about all I can do. My, my level of satisfaction sexually, uh, is, uh...uh, if we were to get super personal, I don't know how personal you wanna, wanna get in regards to the matter except. Um, um... I don't, I don't...

Q: I guess what I'm, what I'm getting at is, you said y'all did share sexual explicit pictures and text messages.

A: Yes sir.

Q: Have you ever sent her text message of yourself nude?

A: Yes sir.

Q: Has she ever sent text messages, uh, pictures of herself nude?

A: Yes sir.

Q: But you're saying that you're, you guys in person never had any type of physical contact?

A: That-- uh, no, I-I wouldn't go so far as to say that, no sir.

A: Uh, the-- I think your question was th-- was there any kind of sexual contact between me and her and, uh, th-that would be, uh, there, there was, uh, uh, oral contact, uh, that I definitely would, uh, re-remember, um...

Q: Oral contact between both of you, you guys?

A: Um...

Q: I know that to-- don't sound too explicit, but you doing her or she doing you or both?

A: Uh, d-d-- me doing her.

O: How often did this take place?

A: Over the course of the relationship, I would say probably twice.

Q: Uh, I'm gonna re-- probably gonna revisit a couple of things just to make sure that I we know, uh... When you had her cleaning your apartment, uh, occasionally spending the night, uh, occasionally having this contact, her case, uh, in which you were the primary investigator, was still active at that time?

A: Yes sir. Yes sir, but it, uh, the-the-- she had, uh, been in contact with, uh, the prosecutors and from what, uh, what explained, what she explained to me was that they basically told her, uh, that she would be used as a witness in the particular case as long as, uh, she was telling the truth, uh, from what the statement that she had given. And they told her that, uh, that ultimately, uh, the, the-the, uh, the case involving, uh, the homicide would, uh, get dismissed and, uh... Q: Yes, y-yes, your, uh, your Watson audit history shows these searches and Watson will automatically search the NCIC database.

I don't remember exactly the timeframe when she had it. Uh, it would've been after, uh, December because I remember mentioning to her, uh, because I-I, I do it with several of, of people involved with my cases.

Q: Well that wouldn't be the one we talking about. We're talking about when you ran her December the 12th. 2018.

A: If that was, a-again, I don't know why it would even have been run that many times. Um, but let me ask you this -- the, the text message that you showed where she mentions the Haywood County thing, that was, that was...way before, uh...

O: Well, that's why we're asking the questions--

A: That was way before that-- I have-- I wasn't even talking to her cus-- you-- Tell me the date again, December the what?

Q: December the 12th.

A: Okay, December the 12th was...

Q: 2018.

A: ...right close to when my daughter was getting ready to graduate from college. I had not been talking to Ms. Stafford at least since... I know that I had, had drifted away and cut communications with her November, uh, and that's when I think, where I think those messages came from. Cus I never-- If I ran that on December the 12th, that was me personally, there was no relationship. I wasn't even talking to her because I-- We can go back. I think my daughter--

Q: So it, so it would be personal?

A: Check. Correct. It was not in conjunction with the communication with her.

O: Okay. So it would be personal.

A: It, it would've been because she, there, there ultimately was one -- again, my daughter graduated from college, and while we were gone, um, um, when I came back -- and I wanna say it was like, it was, it was the first part of December, uh, that, uh, I noticed that there were three charges on my account. So I was, uh, probably-- if I ran it like that, I was probably tryna see-- I assumed it was her, but again, there was no concrete proof. And the reason I assumed is because where the charges were and what they were for.

Q: What, they got-- what you say had got stolen again?

A: My, my debit card?

O: Your debit card?

A: Uh, it-it didn't get, my debit card didn't get stolen. What happened was when I, when I came back from, uh, my daughter's graduation, I checked my bank account, um, because I had spent out on-on her, uh, up there and was gonna give her some more money. Uh, when I checked it, it didn't have the mou-- amount that I had calculated in my mind that it should have. Uh, so I started looking back, uh, at the charges and noted that there were three, if I remember, three or four charges and, um, that I had not made. Uh, I called Regions Bank to verify that this was, had been done and they asked me if I still had my card. I was like, "Yeah, I got it right here with me." Uh, they said, uh...they said, uh, "Well, it looks like somebody paid a light bill, somebody ordered pizza, somebody tried to order some books or something, and they used the card." And I said, "Well, ma'am, I-I didn't make these charges." And-And the, the light bill was attempted to be paid in Tipton County to a power company in Tipton County. One of the last-last conversations that I had with her before I went on the trip, uh, she went and texted me -- I had stopped communicating with her -- was that she was sitting in the dark. I actually sent her money on one occasion, Cash App, for her to pay it, and two days later, she was like, "Oh, I'm..." she was like, "I'm in the dark." And I was like, you know, I didn't even respond.

And that when I had called and found out how much the ticket, I was taken aback and, um, uh, I said that I, that uh, I would get it, uh, would make it back just through working.

Q: And you said you told that to, informally to someone?

A: Yes, to someone, yes.

Q: Was it a supervisor? That you told this to?
