NARRATIVE

On 07/27/2020 Sgt. Lott and I were dispatched to the B Checkpoint in-regards to a found firearm in a passenger's handbag (35.0439592, -89.9821971). Upon my arrival, I observed an image on the x-ray machine monitor on lane #5 of what appeared to be a handgun. I confirmed the owner of the handbag to be Ms. Carolyn Renee Harris. I located a black EIG, E4, .22 caliber revolver, Serial # 81670. The handgun was loaded with 6 rounds in the cylinder, and one of the rounds was empty. Ms. Harris was escorted to the Police substation where warrant and gun queries were conducted which yielded negative results. A criminal history was performed by Sgt. Lott, which came back positive for a convicted felon charge. Ms. Harris stated she forgot to remove the weapon from her handbag before coming to the airport. Ms. Harris stated she was carrying the handgun due to an altercation with another person, which she stated threatened her life on 07/26/2020. The FBI was notified, and Sgt. Lott took photos. FBI agent Durfee advised they will not pursue criminal charges. Ms. Harris does not possess a valid handgun carry permit. Ms. Harris was charged with Unlawful Possession of a Firearm (by a felon) (TCA 39-17-1307). Ms. Harris was searched, handcuffed, and transported to jail east. The firearm was boxed and placed in Police headquarters evidence locker #5.
